Executive Officer's Report



Throughout the year, our Specialist Practice
Networks and State Groups also ran a series of
educational workshops nationally with close to
1,000 participants in over 20 events. These events
provided members the opportunity to network
in a local setting, and discuss topical issues and
problems faced by their patients.

We are also in the process of introducing two new SPNs to provide networks for those interested in Genito Urinary Cancer and Older Persons with Cancer, and have added a new North Queensland and Northern Territory State Group to ensure we have a voice for our members in this region.

We've also welcomed two new editors to the AJCN, along with new Chairs and Committee Members to our Research Standing Committee and Education Standing Committee, and formed a new Communications Standing Committee to improve the way we interact with our members and stakeholders alike.

It has been a year of growth with record numbers at the 2019 Annual Congress, our membership numbers continuing to swell, the introduction of a new education platform offering free CPD for our members and the highest interaction yet with Sosido, our knowledge-sharing platform.

We also introduced several member benefits, as we moved towards a stronger online presence to allow members to engage with the Society at a time that works for them.

These benefits included:

- A second year of access to the WCEA CPD platform, allowing our members to access world class CPD 24/7. An app version is also currently in development – watch this space for an announcement coming soon.
- Two more years of access to Sosido, allowing cancer nurses to communicate important announcements, keeping CNSA members updated with the latest research impacting their practice, whilst fostering a community where members can crowdsource information, discuss trending topics and network with peers.
- The move from a hardcopy journal to an online publication, with the Australian Journal of Cancer Nursing now available through a digital platform.

CNSA also continued to award education and research grants for members, including:

- Nine professional development grants to support members attending national/international professional development events
- A research grant of \$15,000 to support a project exploring "Specialist Cancer Nurses" Engagement in Clinical Supervision"

The impact of COVID-19 cannot be ignored, but we believe CNSA has grown from strength to strength as we moved our education online and introduced a series of weekly webinars for our members and the wider nursing workforce on wide-ranging topics, such as wellbeing, telehealth, advance care planning, Voluntary Assisted Dying, Lung Cancer, NeuroEndocrine Cancer, Bladder Cancer and Immunotherapy.

This online engagement has been very positively received by CNSA members who now have access to consistent national CPD regardless of location – all included in their annual membership subscription. These will be a mainstay of CNSA education going forward, to complement our face-to-face events and Annual Congress.

This has been my first year as the Executive Officer of CNSA, and I would like to take this opportunity to acknowledge the support of the Board of Directors, our industry and government stakeholders, our incredible volunteers but most of all our members for your ongoing commitment to the Society - we couldn't do this without you.

EXECUTIVE OFFICER



President's Report

We have had a very busy period of self-reflection over the past twelve months, resulting in change to help ensure good governance, organisational sustainability and operational efficiency.



As presented at the 2019 AGM, the Board of Directors developed a new Strategic Plan – including a consumer-focused vision, revised organisational values and four strategic priorities (Our Learning, Our Voice, Our Members and Our Organisation) – which was officially launched at our Annual Congress.

This Plan has helped focus CNSA's output for the past 12 months, and will continue to guide us to ensure we are working towards our mission of Promoting excellence in cancer care and control through the professional contribution of Cancer Nurses.

Whilst developing the Plan, the Board of Directors adapted the organisational structure – including the allocation of portfolios to Board Directors, a position description for each Director portfolio, and the establishment of new Board sub-Committees and standing Committees to help achieve our strategic priorities.

The Society also changed our business support model, with the move to an association management organisation to provide membership services, secretarial and operational support, as well as Executive Officer and Company Secretary services.

CNSA has also been an active member of the Radiation Oncology Alliance in collaboration with the Faculty of Radiation Oncology of The Royal Australian and New Zealand College of Radiologists, the Australian Society of Medical Imaging and Radiation Therapy and the Australasian College of Physical Scientists and Engineers in Medicine.

As a member of the Alliance, a collaboration between the radiation therapy professions in the areas of quality, standards, workforce and public interest, CNSA has also been given an opportunity to progress shared interests with constituent members. To support this, the CNSA Radiation Oncology SPN has commenced a partnership with colleagues in New Zealand to better understand and articulate nursing workforce needs in the context of safe quality radiation oncology care delivery. This work is in its formative stages and we look forward to being able to report as work progresses.

We had also commenced planning for our 2020 Congress prior to the COVID-19 pandemic. As we continued to realise the seriousness of the spread of the virus, and the government restrictions came in to play, we made the decision to postpone this event to the same date and venue in 2021. CNSA's 23rd Annual Congress will now be held from 17 – 19 June 2021 at the Brisbane Convention Centre.

The impact of the pandemic has allowed a rethink of CNSA's operational priorities and has led to an increased focus on developing a sustainable business model and a wider reach. The introduction of our new eNewsletter – Cancer Nursing Matters – has

moved our regular communications from a quarterly publication to a weekly bulletin full of relevant and timely information for members and stakeholders. This was launched on World Cancer Day and is one of many initiatives we have rolled out in 2020, as we also celebrate the International Year of the Nurse and Midwife, as designated by the World Health Organization in honour of the 200th birth anniversary of Florence Nightingale.

Since launching this eNewsletter in February, we have been able to provide our members with a range of COVID-19 resources and be on the front foot in terms of information flow. This process has kept our members up to date with fact sheets, research, patient information, government updates and education.

To celebrate World Health Day, CNSA announced the formation of a new community on Sosido - the Global Nursing Alliance on COVID-19 (GNAC-19). It connects all of the 7,500+ nurses currently on Sosido from Canada, the USA, the UK and other countries, to support the sharing of research, experience and ideas about the best ways to manage the challenges of the COVID-19 crisis. This initiative was spearheaded by CNSA, with the support of Sosido, and we believe it will grow in scale as more nursing organisations are invited to participate.

We also published a statement highlighting the role of members and the wider nursing workforce and their response to the unique set of circumstances that have arisen as a result of the virus. The statement is available on the CNSA website.

We called out that nurses tend to be unsung heroes within healthcare settings, yet are generally the first port of call for patients and their families requesting information and surety during clinical trials and treatment. We felt it was important to highlight that our role was even more paramount during times of pandemic, and the calm, caring and collaborative approach shown to date will be a welcome response for those whose health is compromised.

On Tuesday 12 May, we celebrated International Nurses Day. We celebrated the role of all Nurses globally - of which they number more than 20 million. But we also celebrated our own members, and the role they undertake every day to save lives, provide compassionate care, advocate for their patients and contribute to research as they strive for the best possible outcomes and experiences for all people affected by cancer.

To recognise this, we hosted a live and interactive Q&A session with our Executive Officer Jemma Still, CNSA Director Mei Krishnasamy, ISNCC President Patsy Yates and myself, and discussed why we became nurses, what we've learnt during our career, what advice we have for emerging nurse leaders, and what we love most about being a nurse. The response to the live session was overwhelmingly positive, with more than 1,000 views to date.

We are now looking forward to a big six months as we tackle the effects of COVID 19 on the cancer nursing workforce, and assess the supportive care needs of people affected by cancer both now and into the future.

It will be important for CNSA to work with our members and stakeholders to assess policy and advocacy priorities as we examine and prepare for the impact of COVID on cancer control and incidence.

Our membership numbers have never been higher, and we are delighted to have retained the majority of members despite the impact on the workforce and the Australian economy. We look forward to continuing to deliver significant benefits during what is a difficult time for many, and to supporting the Cancer Nursing workforce as we navigate a new terrain.

Finance Audit and Risk Committee

The 2019-2020 reporting period has once again seen sustained growth in the organisation's total financial equity. There was continued growth in membership subscription income and a healthy return from the 2019 Congress in Melbourne.

The Board, together with the Finance, Audit and Risk committee, continue to manage the cash reserves closely. We have been through a process of recruitment and have a successful partner, in Keep Wealth Partners who will assist us with an investment strategy. Our aim is to find opportunities to reinvest these funds back into member benefits and also to obtain improved financial returns on the cash held. This will be a continued focus into the 2020/21 financial year.

As part of the annual budget program for the organisation, there had been a forecast loss in the 2019-2020 CNSA National budget. The Board intended to draw on existing cash reserves to strengthen the organisation. To support this reinvestment, there was a relatively conservative allocation of member benefits with the focus on operational expenditure to support governance of the association as it continued to transition to the new company structure. Included in the member benefits, \$18,616 was awarded to members through CNSA grants and scholarships program. \$6509 was awarded within the Special Projects allocation and included investment in member benefits such as the WCEA online education platform and Sosido

CNSA Group and Specialist Practice Network finance reporting has highlighted the sustained activity undertaken by these groups, although there is variability in the levels of activity. Over 150 thousand dollars was generated and \$106,147 reinvested back into local member benefits.

In addition to core business, key committee activity in this year have included finalisation of investment principles for the large capital held by CNSA and development of resources to support groups entering contracts on behalf of CNSA.

Overall, the CNSA remains in a sound financial position. CNSA managed to avoid the forecast loss due to some reduced operational expenditure and the attainment of further sponsorships to support key member benefits. CNSA reports an operating surplus of \$46,594 for the year ended 31 March 2020.

The CNSA Ltd is required to satisfy the financial and reporting requirements of the Australian Charities and Not-For-Profit Commission Act 2012; in addition to complying with requirements specified by the Australian Accounting Standards. The annual financial report, statements and notes reflect these disclosure requirements.



INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF THE CANCER NURSES SOCIETY OF AUSTRALIA LIMITED

Report on the Audit of the Financial Report

Opinion

We have audited the financial report, being a special purpose financial report of The Cancer Nurses Society of Australia Limited ('the Company'), which comprises the statement of financial position as at 31 March 2020, the statement of profit or loss and other comprehensive income, the statement of changes in equity and the statement of cash flows for the year ended, and notes to the financial statements, including a summary of significant accounting policies, and the responsible person's declaration.

In our opinion, the accompanying financial report of The Cancer Nurses Society of Australia Limited has been prepared in accordance with Division 60 of the *Australian Charities and Not-for-profits Commission Act 2012*, including:

- i. giving a true and fair view of the Company's financial position as at 31 March 2020 and of its financial performance for the year then ended; and
- ii. complying with Australia Accounting Standards and Division 60 of the Australian Charities and Not-for-profits Commission Regulation 2013.

Basis for Opinion

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described as in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report. We are independent of the Company in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 *Code of Ethics for Professional Accountants* (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter - Basis of accounting

We draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared to for the purpose of fulfilling the Company's financial reporting requirements of the *Corporation Act 2001* and the *Australian Charities and Not-for-profits Commission Act 2012*. As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

Responsibilities of the Board for the Financial Report

The Board is responsible for the preparation of the financial report that gives a true and fair view and have determined that the basis of preparation described in Note 1 to the financial report is appropriate to meet the requirements of the Australian Accounting Standards and Division 60 of the Australian Charities and Not-for-profits Commission Act 2012. The Board's responsibility also includes such internal control as it determines is necessary to enable the preparation of the financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the Board is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board either intends to liquidate the Company or to cease operations, or have no realistic alternative but to do so.



Auditor's Responsibilities for the Audit of the Financial Report

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of the financial report.

As part of an audit in accordance with Australian Auditing Standards, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial report, whether due to
 fraud or error, design and perform audit procedures responsive to those risks, and obtain
 audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of
 not detecting a material misstatement resulting from fraud is higher than for one resulting from
 error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or
 the override of internal control.

The Cancer Nurses Society of Australia Limited Notes to the Financial Statements For the year ended 31 March 2020

The financial report covers The Cancer Nurses Society of Australia Limited as an individual entity. The Cancer Nurses Society of Australia is a not-for-profit entity, registered and domiciled in Australia.

The principal activities of the Company during the year was to act as a resource to cancer nurses around Australia through the provision of services which aim to advance cancer nursing education, practice and research.

The functional and presentation currency of The Cancer Nurses Society of Australia Limited is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

Note 1. Basis of Preparation

In the responsible persons' opinion, the Company is not a reporting entity since there are unlikely to exist users of the financial report who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. This special purpose financial report has been prepared to meet the reporting requirements of the *Australian Charities and Not-for-profits Commission Act 2012*.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101, Presentation of Financial Statements, AASB 107 Statement of Cash Flows, AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054 Australian Additional Disclosures.

Note 2. Summary of Significant Accounting Policies

The accounting policies that have been adopted in the preparation of the statements are as follows:

(a) Income Tax:

The Company is exempt from the payment of income tax pursuant to Section 50-5 of the Income Tax Assessment Act (1997).

(b) Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Company and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable.

All revenue is stated net of the amount of goods and services tax (GST).

Donations

The Company, in common with most organisations dependent upon contributions, is unable to establish control over voluntary donations prior to their initial entry into the accounting records, therefore they are recorded on the basis of cash received.

Member Subscriptions

Member subscriptions are recorded on an accruals basis and apportioned across the year of membership.

Grants and Bequests

The Company receives grants and bequests for certain activities. Where a grant or bequest is non-reciprocal, it is recognised as revenue of the Company upon receipt. Associated expenditure for the completion of a grant or bequest is recorded as incurred. Where a grant or bequest is subject to a reciprocal transfer, a liability associated with the reciprocal transfer is recorded upon receipt of the transfer. The income and expenditure is then subsequently reported at the time of the subsequent grant or bequest.

Interest Revenue

Interest is recognised using the effective interest method and recorded on accrual basis.

Other Income

Other income is recognised on an accruals basis when the Company is entitled to it.

Net Annual Congress Income

The Company contracts a professional Events Co-ordinator to manage the staging of the Annual Congress including the receipt of revenue and payment of expenses in relation to the event. Documents detailing the income and expenses have been received from the Events Co-ordinator together with a reconciling statement. Revenues and expenses associated with the Congress are recognised through the Statement of Profit & Loss and Other Comprehensive Income in the year the Congress is conducted. In the period in the lead up to the Congress, expenditure is incurred and income received which is taken up as prepayments and unearned income respectively. Where there is an excess of funds received by the Events Co-ordinator above an agreed limit, these funds are remitted back to the company and retained within the cashflows.

(c) Goods and services tax (GST)

Revenue, expenses, and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of GST.

The net amount of GST recoverable from, or payable to, the ATO is included as part of receivables or payables in the statement of financial position.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

(d) Property, plant, and equipment

Each class of property, plant and equipment is carried at cost less any accumulated depreciation and impairment. Items of property, plant and equipment acquired for nil or nominal consideration have been recorded at the acquisition date fair value.

Depreciation

Property, plant, and equipment is depreciated on a straight-line basis over the assets useful life to the Company, commencing when the asset is ready for use.

The estimated useful lives used for each class of depreciable asset are shown below:

Fixed asset class	Useful life
Office Equipment	3 years
Computer Equipment	3 years
Web site Development	3 years

At the end of each annual reporting period, the depreciation method, useful life, and residual value of each asset is reviewed. Any revisions are accounted for prospectively as a change in estimate.

(e) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held on call with banks and other short-term highly liquid investments with original maturities of three months or less.

(f) Employee benefits

Provision is made for the Company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

(g) Income in Advance

Income in Advance includes member subscriptions, which have been received for the 2020 membership year, Events income in advance, Other income in advance and Annual Congress income received (Refer to note 2 (b)) or other future income such as sponsorships, which may cover the full proceeding calendar year.

(h) Comparative Figures

Comparative figures have been adjusted to conform to changes in presentation for the current year where required by accounting standards or as a result of changes in accounting policy.

(i) Other Current Assets

Prepayments included in other assets primarily relates to prepayments for the future Annual Congress, insurance premiums, travel expenses and other such expenditure.

(j) Trade and Other Payables

Trade and other payables represent the liabilities for goods and services received by the Company that remain unpaid at year-end. Trade payables are recognised at their transaction price. They are subject to normal credit terms and do not bear interest.

Note 3. Critical Accounting Estimates and Judgments

The responsible persons make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

Key estimates - receivables

The receivables at reporting date have been reviewed to determine whether there is any objective evidence that any of the receivables are impaired. An impairment provision is included for any receivable where the entire balance is not considered collectible. The impairment provision is based on the best information at the reporting date.

Note 4. Nature and objects of the Company

The primary objects for which the Company is established are to achieve and promote excellence in cancer care, prevention and treatment in people affected by cancer through the professional contribution of nurses. To support the primary object the Company will:

- a) promote the contribution that cancer nurses make to Australia's cancer control activities and policy;
- b) take a leadership role in addressing the professional development needs of cancer nurses to enhance their capacity to provide care, treatment and prevention services to people affected by cancer;
- c) collaborate with other groups and organisations involved in the development and provision of care, treatment and prevention services to people affected by cancer;
- d) facilitate research in the area of cancer nursing that will contribute to improvement in care of people affected by cancer;
- e) provide opportunities for professional networking amongst cancer nurses; and
- f) do anything ancillary or incidental to the primary objects.

Note 5. Economic Dependency

The ability of the Company to maintain its current level of operations is dependent on the continuing support of its members by way of voluntary subscriptions.

If the Company is wound up, the constitution states that each member is required to contribute a maximum of \$1 each towards meeting any outstanding and obligations of the Company.

At 31 March 2020, the number of members was 1,228 (2019: 1,267).

Note 15. Events after reporting period

Since the end of the financial year, the outbreak of COVID-19 has occurred, and this is expected to have an impact on the business operations and cashflows of the entity in the current and future financial year. The 2020 Winter Annual Congress has been cancelled, and as a result it is estimated that there will be a \$225,000 decrease in the surplus in the 2020/21 financial year. This will be partly offset by some budgeting restrictions and other new income being generated by the company.

CNSA held our 22nd Annual Congress at the Melbourne Convention and Exhibition Centre. The congress theme of 'The Complexity of Cancer Care: What will the future of cancer nursing look like?' was explored over the three days via a series of pre-congress symposiums, plenary sessions, concurrent sessions and poster presentations.

Our international key note speaker Dr Linda Watson, former President of the Canadian Association of Nurses in Oncology (CANO/ACIO) presented two fantastic sessions on embedding Patient Reported Outcomes (PROs) and also her work on incorporating digital health and change management to transform nursing care. Professor Mei Krishnasamy and Professor Sandie McCarthy also facilitated two thought provoking sessions on the Nurses role in Voluntary Assisted Dying and the role of the Specialist Cancer Nurse.

Feedback from the Congress was overwhelmingly positive with many delegates saying it was the best program to date and provided education to suit all levels of cancer nurses. We were also delighted to have a record-breaking 697 delegates in attendance and a fantastic range of industry stakeholders in the exhibition hall.

Research Standing Committee

The Research Standing Committee (RSC) activities have undergone a lot of changes in the last 12 months. Many of the Committee members had served for extended periods of time, and so soon after Congress in 2019, the Committee welcomed new members and said goodbye to many. We thank all past Committee members for their service, particularly acknowledging those who have contributed for many terms.

The Committee continues to refine its processes and update policies to better reflect the strategic direction of CNSA and the activities of the Committee.

Our workplan now includes activities to support and promote research for each of CNSA's strategic priority and focus areas.

One policy change the Committee sought board approval for, has been streamlining the process for review of surveys requests that are submitted to CNSA for distribution to membership. All surveys distributed to CNSA membership continue to require a CNSA member as part of the investigator team. The Committee receives on average one new survey each month; these are now reviewed by one member of the Committee to ensure they align with the CNSA values and comply with ethical standards. We now also ask investigators to report back the numbers of survey responses from CNSA members.

Topics for survey range from disease or population specific surveys, (e.g. breast cancer or palliative care), to care coordination issues, and symptom management issues. Response rates range from 40-100 responses depending on the topic. The contribution CNSA members make by participating in these surveys not only ensures the voice of cancer nurses is heard, but also supports fellow nurses to undertake research to advance cancer care and cancer control, ultimately benefiting patients' families and health services.

The Committee received seven grant applications in the 2019 rounds, all of which were of a high quality. We were pleased to be able to recommend two studies for funding this year. PhD candidate Priscilla Gates research is exploring the patterns and cognitive changes over the course of treatment and recovery for patient with newly diagnosis lymphoma. As Priscilla's request for funding was less that the funds available for the 2019 grants, we were able to part-fund Anne Williams research application. Anne's research will develop a nurse-led well-being support program for multi-disciplinary staff working in a hospital cancer services. As per CNSA policy, outcomes of these projects will be reported at CNSA Congress and manuscripts published in the AJCN.

The Committee was involved in planning for the 2020 Congress, and along with all other members, disappointed that Congress was deferred due to COVID-19. With the usual activities associated with Congress not proceeding, our focus instead has been on developing plans to support the membership to access relevant research as well as undertake high quality nurse-led research.

The outgoing Committee members developed a survey, which was promoted during Congress 2019, to identify the research priorities of cancer nurses. This survey was completed by over 250 nurses and highlights priorities across a wide range of issues related to workforce, health services and patient related outcomes. The outcomes of this survey are informing the directions for future grant funding, and the Committee look forwards to working with the Board to address these priorities and to advancing cancer care and cancer control in Australia.

Education Standing Committee

The Education Standing Committee (ESC) has worked as a collaborative group of clinicians, educators and researchers to complete a range of work in the 2019-2020 period. We always welcome new members who are interested in promoting education and professional development for cancer nurses.

On behalf of the Committee, I would like to thank last year's Committee members for their work and support of the projects and for their service, dedication and contributions. In 2019, Sarah Northfield resigned from the Committee and two of our members re-nominated to stay on the Committee; Thea Ogle and Ola Akinsanmi. I would also like to acknowledge the work undertaken by Violet Platt who has stepped down from the position of Board Director and the Education portfolio.

Following a call for nominations, we welcomed new members Carla Thamm, Michelle Rosano, Dr. Catherine Patterson, Margaret Hjorth, Joanie Shaw and Angela Ballard. All these members bring a wealth of knowledge and clinical experience to the Committee. Additionally, as all these members work in various health care settings, they bring various lenses to the needs of educational needs of our CNSA membership.

One of the main roles of the ESC is the administration of the professional development and travel grants, which includes maintaining and reviewing

the framework for submission requirements and scoring criteria prior to the grant process. However, due to the CoVID-19 pandemic the professional development and travel grants were paused until 2021.

With this in mind, we would like to remind the members the process for Professional Development and Travel Grants is as follows:

- All submitted grants are blinded prior to assessment to ensure the equity of the review.
- A process of moderation is undertaken, where two grants are scored by all reviewers and the scores and comments are checked to make sure the selected reviewers are grading consistently.
- All reviewers are asked to declare any conflicts of interest prior to commencing the grading process.
- Each submitted grant application is then reviewed by three members.
- Once each submission is scored by three members, the mean score is the final score.
- Grants are awarded to the highest score in each category, with the aim to allocate funds to all grants with a mean score above 15, where resources allow.

For those interested in more information, we recommend visiting the CNSA website for a full explanation of the process and submission requirements. We encourage any CNSA member who is putting together a CNSA Professional Development and Travel Grant application to contact ESC members if they would like any advice or have any questions about the process – email education@cnsa.org.au.

The Committee has commenced the submission for a CNSA research project to identify the educational needs, interests and priorities of the Australian cancer nurse. It is anticipated that this new knowledge will enable the ESC to tailor the learning activities and educational platforms to the learning needs of our constituents. Once this work has been completed and strategies implemented to meet the needs of the CNSA membership, a follow-up survey will be conducted to gain feedback to investigate if the strategies the Committee had implemented were effective.

In closing, the Education Committee has contributed to CNSA by investigating our current understanding of what are the potential educational needs of the Australian cancer nurse.

Communications Committee

The CNSA Communications Committee was formed in 2019, and first met at Congress to discuss our priorities, goals and challenges for the next 12 months.


Members of the Editorial Board include a member of the CNSA Executive and four ordinary members.

Online publication

In 2019 the journal moved to mainly an online publication with hard copies being available to members who 'opt in'. There were 219 copies posted for issue one and 320 for issue two last year. From 2020 hard copies will only be available by paid subscription to the journal. Sixteen individuals have elected to pay for hard copies this year. The publication, distribution and postage of the journal continues to be undertaken by Cambridge Media in Perth.

We have recognised that the online presence of the journal is currently challenging to locate, as members must login and click on the journal site before they can see the table of contents. We are working on an online strategy to ensure the presence of the journal is more publicly available to entice readers in and encourage the dissemination of the important work of the authors. Having the journal hosted one click away from the landing page, with the table of contents and abstract available to view by all would encourage more readers beyond the CNSA membership to read the articles which would in turn be more attractive to authors.

To help promote the published work of the journal authors and disseminate the research and practice development for the benefit of nurses working in cancer care, we are looking to undertake the following:

1. Increasing the number of peer reviewers


- a. The Editors will publish a call for reviewers in the next issue of the journal and the CNSA newsletter.



Breast Oncology Nurses Specialist Practice Network

Congress 2019

We held a special practice meeting June 20 prior to commencement of the annual Congress where we workshopped educational interests to inform session development at future Congress/conferences breast care nurses were likely to attend. The Australasian Society for Breast Disease conference was identified as a key event for the 2019 year and it was proposed by members that we scope a dinner event that could include presentations around meeting the needs of complex patients. Members were seeking advice around strategies to manage patients with history of mental health disorders and to learn about supports available. In addition, there was interest to discuss strategies for self-care, especially in managing patients who may seek alternative treatments.

On Day 2 of Congress we hosted a breast oncology session on clinical trials in breast cancer. This interactive session aimed to educate cancer nurses and allied health professionals on the utility of clinical trials in cancer. Focussing on breast cancer trials and covering neoadjuvant, surgical and metastatic clinical trials, we explored the benefits of clinical trials for patients and how

to navigate barriers to recruitment. Our expert group provided tips on how to advocate for patients and empower patients themselves to discuss being involved in all phase clinical trials. Presenters included: Prof Bruce Mann, A/Prof Elisabeth Elder, Dr Ben Forster, Jenny Gilchrist and Danielle Spence.

Australian Society of Breast Disease Conference 2019

In response to member feedback, we held a dinner meeting supported by GenesisCare/ McGrath Foundation and Cancer Nurses Society of Australia at the ASBD conference on the Gold Coast on Friday 11th October. The topic was Managing Communication Challenges in Complex patients.

The event attracted 64 attendees and included:

- BCNA presenting the new My Journey Online tool for Breast Care Nurses to use for their patients.
- GenesisCare presenting new techniques and services
- McGrath presenting the new model of care underway.
- Psychologists spending time with the audience to generate a discussion about real practice examples of complex patients

Participants commented that they would like more formal communication training and not all breast care nurses have access to clinical supervision. Future events have been impacted by the COVID-19 pandemic with the cancellation of Congress. We have therefore focused our efforts on education delivery via digital platforms.

Webinars

The leadership of the Breast Oncology Nurses Specialist Practice Network have been active during this time, helping to develop several webinars that have been actively promoted to our membership.

VCCC COVID-19 and Cancer in Victoria: enhancing communication skills for telehealth delivery

The VCCC COVID-19 and Cancer in Victoria: enhancing communication skills for telehealth delivery was facilitated by Danielle Spence and open to registration nationally. Discussion focused on the rapid uptake of telehealth as a result of COVID-19. We workshopped how the fast pace of change, has meant the sector has had to develop and implement 'how to' guides and best practice around the implementation and use of telehealth for both health professionals and consumers. The nature of telehealth requires healthcare professionals to structure their consultations with patients differently to optimise the experience for everyone involved. It seems that regular use of telehealth for patient consultations will be part of the 'new normal' across health care once the pandemic subsides and co-design models will be required to ensure the best outcomes for patients and families.

We encourage our members to get involved in research and evaluation around effectiveness of telehealth in cancer care to ensure we develop sustainable and effective models post the pandemic response.

Impacts of COVID-19 on Cancer and Cancer Nursing

This webinar provided practical advice and case studies directly relevant to Oncology nurses, with a focus on the direct impacts of COVID-19 on the cancer nursing workforce. Discussion areas included:

- An overview of the supportive care needs of people affected by cancer both now and into the future
- Clinical ethics and decision making
- Policy and advocacy priorities as we examine and prepare for the impact of COVID-19 on cancer incidence

Facilitated by Danielle Spence, guest speakers included Professor Sanchia Aranda, CCA, Professor Clare Delany, The University of Melbourne; A/Prof Lesley Stafford, Royal Women's Hospital and Katherine Lane, CCV. During the webinar we workshopped some of the changes nurses have faced including supporting patients and families through psychological trauma associated with treatment planning in the midst of a pandemic, impact of visitor restrictions and bereavement distress some people have experienced if restricted from being with those they love at end of life care.

Scholarships

We were able to secure a scholarship opportunity for Cancer Council Victoria's Clinical Consultation Skills Retreat at Torquay Victoria in October 2019. All Victorian-based nurses working in full or in part with people living with cancer that were Full Members of CNSA were eligible to apply. The retreat, delivered in partnership with Deakin University, was designed specifically to enhance core communication skills and mentoring capabilities for clinical scenarios, including delivering bad news and discussing end-of-life care.

The successful applicant was Gill Kruss Metastatic Breast Cancer Nurse Practitioner Monash Medical Centre Moorabbin|Monash Cancer Centre who is a member of the Breast Oncology Nurses Specialist Practice Network.

Committee Representation

Influencing policy that impacts on our members' practice and people affected by breast cancer remains a strong interest to the Breast Oncology Nurses Specialist Practice Network. Over the past twelve months the leadership group have continued to work with the McGrath Foundation to provide expertise in the development of their new model of care. Jenny Gilchrist is represented on the Expert Reference Group and Danielle Spence is represented on the Expert Working Group.

Several of our members were also involved in the steering group or the expert working groups for Cancer Australia's Draft Guidance for the Management of Early Breast Cancer. Through these expert groups we have been able to advocate for: "All patients with a potential or known diagnosis of breast cancer to have access to information and support at every stage of diagnosis, treatment and follow-up. A key contact person, ideally a breast care nurse, should be agreed as soon as possible (within 7 days is optimal) to support communication and coordination of patient-centred care. We also promoted that in regional or remote areas, consultations may be via telephone and/or video conferencing calls.

Cancer Nurse Practitioner Specialist Practice Network

The CNSA CNP SPN has continued to provide quality education and support to our members over the 2019/2020 period. The SPN has seen membership remain steady with 65 current active members down from 66 2018/2019 this in spite of significant change and disruption caused by the COVID -19 pandemic.

The main focus of the CNP SPN continues to be on providing excellent and relevant education targeted toward Nurse Practitioners working in a variety of cancer related specialties. 34 members attended the Dermatology issues in cancer workshop held at the Pan pacific hotel in Perth on the 9th September 2019. The main speakers for the day included renowned dermatologist Pablo Fernandez Peñas and wound care nurse practitioner Margi Moncrieff. The workshop was well received by all that attended. Unfortunately, the main 2-day workshop for 2020 focussing on mental health, wellbeing and nurse practitioner resilience was cancelled due to the COVID -19 pandemic.

Gynaecological Oncology Specialist Practice Network

The CNSA Gynaecological Oncology Nurses Specialist Practice Network (GYN SPN) was established in 2011 and has grown to 165 current members, including nurses working in both the public and private sector across Australia and New Zealand. The GYN SPN members are kept abreast of relevant information through the CNSA newsletter and email updates.

Anne Mellon continues in the role of Chair of the GYN SPN, with Bronwyn Jennings as Deputy Chair and Olivia Cook as Secretary. GYN SPN Committee members include Danielle Carpenter, Natalie Williams, Belinda Zeilony, Nicole Kinnane and Isobel Black. The Committee has held 2 Committee meetings during this year.

The CNSA GYN SPN were successful in their application to hold a Gynaeoncology Pre-Congress Symposium in 2020, an opportunity for those working in the area of Gynaeoncology to participate in professional development with a specialty focus.

The educational content of the symposium included both current and innovative models of care in the management of gynaecological cancer. Due to the cancellation of Annual Congress in 2020 this did not go ahead, but is planned for inclusion in the program for Annual Congress 2021.

The nurses' workshop at the International Gynecologic Cancer Society Annual Global Meeting in Rio de Janeiro, Brazil in September 2019 was a great success. Topics presented included global perspective of gynaecological cancer; cancer nursing in South America; cervical cancer program in Latin America; sexuality and gynaeoncology patients; and a panel discussion on endometrial cancer in Brazil. Despite the small number of attendees, those that participated included leaders in oncology nursing in Brazil. Robust discussion was had in relation to all topics and the panel discussion was a breakthrough for Brazilian nurses as it was the first time they have been included in the dialogue with doctors regarding the endometrial cancer epidemic in Latin America. It was fantastic to be able to facilitate such a ground breaking experience for them, something that we in Australia take for granted within our multidisciplinary teams.

The year 2020 marked ANZGOG's 20th anniversary and the ASM promised to be a fantastic occasion. The program for the nurses' workshop had been finalised and planned to focus on wellbeing and Gynaeoncology advanced nursing practice. Due to the ASM being cancelled in 2020, the workshop will be included in the program for the ANZGOG ASM 2021.

Radiation Oncology Nurses Specialist Practice Network

The Radiation Oncology Nurses Special Practice Network (RON SPN) comprises of 10 passionate nurses from 5 Australian states. As Committee members we aim to facilitate nursing knowledge and nursing skills around the theory of radiation therapy and the management of acute and late treatment side effects. We also aim to educate the wider nursing community to the value and importance of well-educated radiotherapy nurses.

We meet face to face annually at the CNSA conference and participate in teleconferences throughout the year.

What's new from the past year?

• Radiation Oncology Alliance

Following on from last year's invitation to join the Radiation Oncology Alliance we have been involved in a working party to incorporate the "Practice Principles for the care of patients undergoing radiation therapy" into the Alliances' Radiation Oncology Practice Standards (ROPS) document.

We also provide input and feedback on Alliance initiatives, ie: AIDA (Australian Indigenous Doctor's Association), Establishing and Sustaining Reginal, Rural and Remote Radiation Therapy Centres.

Radiation Oncology Model of Care Scoping Survey

The RON SPN are in the final stages of drafting a scoping document to inform us on what other centres around Australia are doing in terms of nursing care for the patient receiving radiation therapy in order to develop a "national" radiation oncology model of care.

Once the draft is complete, this document will be distributed to cancer centres' around Australia, we as a group will then collate the response and formulate a model of care.

CNSA Annual Conference

How disappointing that this year's CNSA conference had to be cancelled due to the COVID-19 crisis.

We were very excited at the prospect of our Pre-Congress Rad Onc Symposium "Radiation Therapy: The epitome of Precision Care Everywhere".

Vascular Access Device & Infusion Therapy Specialist Practice Network

At the 2019 Annual Congress the Vascular Access Device & Infusion Therapy Specialist Practice Network (VAD&IT SPN) ran a pre-congress workshop sponsored by 3M titled "Skin in the game: protecting vulnerable skin and CVAD securement".

Thirty one CNSA members attended this pre-congress workshop which focused on the prevention of medical adhesive related skin injury (MARSI), the appropriate use of CVAD dressings and dressing management with topics including anatomy and physiology of the skin, pathophysiology of skin in

patients diagnosed with cancer, MARSI incidents and prevention, prevalence of impaired skin surrounding devices in cancer care and the principles of dressing management.

The interactive sessions offered paediatric and adult patient case study discussions with group input into the prevention and management of infection, wound management, extravasation management, and appropriate dressing management for IV/CVAD care in the cancer population. To finish the day participants were provided with the tools to implement a CVAD associated skin impairment algorithm in their own hospitals.

The VAD&IT SPN received Special Project Funding from the CNSA Board to conduct a vigorous systemic review of the literature to update the CNSA Central Venous Access Devices: Principles for Nursing Practice and Education Guidelines from 2007. The scope has altered to include peripheral as well as central venous access devices and paediatric and adults.

This was as a result of the collaborative CNSA / eviQ project in 2013 which identified the CNSA CVAD Guidelines, 2007 were a unique and critical document for cancer nurses to assist and guide clinical practice. The CNSA VAD&IT SPN embraced the challenge to revise the document, topic by topic. The content will be readily available for all cancer clinicians using the Cancer Council Australia wiki platform.

An extensive search of the literature was run in March 2019 and over 5000 articles were screened, resulting in 111 articles for data extraction to assist with answering the most complex clinical questions on vascular access & management in cancer care. This work completed thus far, aligns with the rigorous methodology of a systematic review and is close to being ready for public review.

This project, once completed, will provide direct links to the most up to date & relevant resources available from both CNSA & third parties, to provide clinicians with the tools to provide best practice vascular access & management care to patients throughout Australia & New Zealand.
