PRESIDENT'S REPORT



Over the past 12 months, the National Executive Committee (NEC) has focused our efforts on enacting a number of key measures to ensure the CNSA will have a robust governance infrastructure going forward. These measures include, but are not limited to the constitutional review, appointment of the Chief Executive Officer (CEO), governance training for the NEC, and development of a strategic plan for 2017-2021. Ensuring the success of these measures has been challenging and complex, but I would like to acknowledge the relentless courage and professionalism of the NEC and staff, which has been key to the success of these measures.

While these measures/projects have taken up a considerable amount of time and effort of the NEC and staff, I am confident that each of these projects will be essential to the future growth and sustainability of the organisation. These efforts will lead to a number of

short-term and long-term gains. We expect some of these to be realised within the 2017-2018 reporting period. It would be remiss of me to not make a special mention of the significant contribution of the Constitution Review Steering Committee. Thank you to Sandy McKiernan, Deborah Hoberg, Catherine Johnson, Anne Mellon and Patsy Yates. The approval of relevant special resolutions by the membership at the Annual General Meeting was a testament to the quality work undertaken by the committee and the NEC.

The CEO appointment is a key milestone of growth for the CNSA, as well as a sign of maturity as the organisation steps into our 20th Anniversary. Since the appointment of Ms. Samantha Gibson, the support received by members and stakeholders (from both internal and external to the organisation) has been overwhelming. I am confident that Samantha will be able to lead the organisation to the next level of success.

I would like to specifically commend Mr. Trevor Saunders (CNSA Immediate Past Treasurer) for his leadership over the financial governance of this organisation. As Chair of the Finance and Audit Committee, he has led the centralisation of finances of all Regional Groups (RGs) and Specialist Practice Networks (SPNs) over the past 24 months. This project does not only raise the standard of financial governance of the organisation, it also allows the RGs and SPNs to focus on their operational priorities and local educational initiatives. It is very clear that the CNSA is in a financially strong position. We are mindful that the financial reserves of the organisation will allow us to invest in initiatives and strategies that will result in members' benefits.

Over the past 12 months, we have funded eight professional development travel grants (three offered by regional groups) and two research grants. While I am pleased with these outcomes, the Education Standing Committee has continued concerns about grants being incomplete and consequently the sub-optimal success rates for travel grants. Over the next 12 months, the Education Standing Committee and the NEC will work together to implement capacity building strategies to equip members with grant writing skills. From a research perspective, the CNSA has been providing a well-attended research pre-Congress workshop over the past 2 years where novice researchers receive mentoring and support as they develop a research concept. We are currently working with the Primary Care Collaborative Cancer Clinical Trials Group to offer a joint research workshop that will focus on cancer survivorship. In addition to the grants above, the NEC has also extended the project timelines for the two special projects led by Professor Sandie McCarthy and the Education Standing Committee. These extensions will allow the teams to be able to deliver on the expected outcomes and disseminate the findings of their projects.

In February 2017, the CNSA launched Sosido for our members. Sosido enables members to keep track of the latest publications of CNSA members and the latest literature on cancer nursing and supportive care. The next step will be for members to access the community forum, where members can have professional interactions and discussions. I have received great feedback from our members about this initiative.

Developing and maintaining national and international partnerships remains a key focus for the CNSA. The CNSA was represented at a number of committees of our partner organisations including: International Society of Nurses in Cancer Care; Cancer Australia; Clinical Oncology Society of Australia; Coalition of National Nursing and Midwifery Organisation; Psycho Oncology Collaborative Research Group; and Australian New Zealand Urogenital and Prostate Cancer Trials Group. The CNSA has also made concerted efforts to enhance our partnership with the Canadian Association of Nurses in Oncology and the New Zealand's Cancer Nurses College.

If the membership approve the motion to register CNSA as a public company limited by guarantee with the Australian Securities and Investments Commission (ASIC), and approve the proposed constitution, the new constitution will come into effect upon registration with ASIC. The Board of Directors will then be nominating the new CNSA President from within the Board. This will also mark the end of my term as CNSA President. I am very pleased with the productive, collaborative relationship I have shared with Ms. Jane Campbell (President Elect) and the remainder of the NEC over the past three years. Jane's tremendous professionalism, dedication, and support to my leadership is well recognised. I am very confident that Jane, the Board and CNSA staff will take the organisation to greater heights, ultimately benefiting our members and people affected by cancer.

In closing, I would like to conclude my report by expressing the privilege that I have had to serve CNSA members. The leadership journey over the past 12 months has been a highlight of my career. I look forward to contributing to the Society in other ways and witnessing future growth of the organisation

TREASURER'S REPORT



On behalf of the National Executive Committee (NEC) and the Finance and Audit Committee (FAC), I am pleased to inform members that the 2016-2017 reporting period has once

(FAC), I am pleased to inform members that the 2016-2017 reporting period has once again seen sustained growth in the organisation's total financial equity. I acknowledge the huge contribution that my predecessor Trevor Saunders has played in ensuring the financial management of CNSA is responsible and considered. CNSA also benefits from strong and productive partnerships with our bookkeeper and accountant; relationships that Trevor has fostered and enhanced for the betterment of our Society. In taking on the Treasurer role in the wake of numerous changes in the governance of CNSA, I have been reassured by the strong foundation and vision of the FAC to remain responsive to current and future challenges and opportunities.

In this reporting period, key income streams remain member subscriptions and Annual Congress. Continued growth in membership subscription income amounted to almost

\$157,000 for the year ending 31 March 2017. The 2016 CNSA Annual Congress in Cairns attracted strong attendances and sponsorship. Annual Congress 2016 was the most financially successful Congress in history, with \$422,675 in support and exhibition sales, an increase of over \$28,000 from the 2015 Winter Congress in Perth. After disbursements and management fees were paid, CNSA netted a record net profit for 2016 of just over \$218,000.

Building on the prudent investment approach in previous years, and to mitigate against current low interest rates, the NEC and FAC have strategically expanded the CNSA investment portfolio to maximise returns on the significant financial assets held by the CNSA. Funds currently held in investment are just over \$812,000 with interest income of over \$12,300 received in this financial year.

The NEC and FAC have a key responsibility to members to maintain and extend the assets of the organisation, to support activities in line with the strategic goals of CNSA. The financial stability of the Society has enabled an increased allocation, in 2016-2017, toward member benefits. Over \$27,000 was awarded to members through CNSA grants and scholarships. Over \$17,500 was awarded within the Special Projects Program to develop professional development resources and activities.

CNSA Regional Group and Specialist Practice Network finance reporting has highlighted the extraordinary amount of activity undertaken by these groups. Almost \$170,000 income was generated and \$143, 514 reinvested back into local member benefits.

Overall, the CNSA remains in a sound financial position with a total equity of \$854,415 and an operating surplus of \$85,515 for the year ended 31 March 2017. This surplus is testament to the sound fiduciary management by the NEC and FAC in balancing expenditure related to necessary administration, employment and legal costs incurred by the Society in this financial year. As an incorporated association in Australia, the CNSA is required to satisfy the financial and reporting requirements of the Associations Incorporation Act 1991 (ACT), in addition to complying with requirements specified by the Australian Accounting Standards. The accompanying annual financial report, statements and notes reflect these disclosure requirements.

WEBSITE AND COMMUNICATIONS



The CNSA social media profile has continued to grow over the past year, with the Twitter feed and Facebook page serving as a platform for regular communication and news to our members, aided with attracting some new members. At the end of the reporting period, the Twitter feed had 900 followers, an increase of 183 followers. The CNSA Facebook page had 1543 likes, representing an increase of 437 likes.

The CNSA Communications Officer, along with Chilli Fox Events, continue to maintain the social media platform for CNSA. A social media plan has been developed with monthly themes, member profiles, Fact Fridays and posting relevant news stories and information from like-minded organisations. Social media themes highlighted over the past year have included; lifestyle and risk reduction, bowel cancer, head and neck cancer, venous access device and infusion therapy, childhood cancer, breast cancer, blood cancer, lung cancer, geriatric oncology, prostate cancer, ovarian cancer and palliative and end-of-life care.

The publication of the newsletter continues to be an important part of the CNSA communication strategy. This is distributed via email to CNSA members and posted on the CNSA website on a quarterly basis, with contributions from the President, Regional Groups, Specialist Practice Networks and CNSA committees and working groups.

19TH ANNUAL CONGRESS REPORT

The National Executive Committee chose Cairns as the location for the 2016 Annual Congress. The location lent itself to the theme "Bridging the Gap" – Distance, Culture, Workforce & Knowledge. The theme, location and program attracted 560 delegates from a diverse range of cancer nursing disciplines including clinical, research, management, education and executive.

As the gateway to the Asia Pacific region, boasting two world heritage listings, the Great Barrier Reef and the ancient tropical rainforests, many delegates chose to stay on and enjoy the offerings of the region. Delegates fulfilled their professional development needs, met up with friends and colleagues, networked with industry and took time to enjoy the freshest local produce and world renowned scenery and landscapes.

Delegates were treated to three high calibre international speakers. The draw card for the 19th Annual Congress was the acclaimed and engaging international keynote speaker, Professor Margaret Barton-Burke from The Memorial Sloan Kettering Cancer Centre New York. Margaret spoke of her work in recognising and addressing the care needs of women with breast cancer from disparate populations. She challenged delegates to think beyond their own backyard and participate in global healthcare reform. Her message was further enhanced by an unforgettable plenary address from Cancer Council CEO, Professor Sanchia Aranda, who left the audience captured by her informed, educated and forceful address that insisted that as nurses, we must take a seat at the table and broaden our vision.

Widely published and highly regarded vascular access experts Jocelyn Hill from Vancouver Canada and Associate Professor Nancy Moreau from Greenville, USA, provided up to date insights into current research and evidence in the vascular access domain. Delegates had opportunities to hear from Jocelyn and Nancy in the pre-Congress arena and the plenary program and connect with these two leaders during Congress. Jocelyn's attendance was generously supported by Angio Dynamics and Nancy's by TeleFlex.

Professor Bill Runciman from South Australia ignited delegates with an entertaining and reflective presentation focusing on quality and safety in healthcare, reminding the audience of the responsibility that nurses play in contributing to a safe and efficient health care environment. His presentation was complimented by the legendary Patricia Staunton AM, who spoke extensively on the legal ramifications and obligations that nurses are bound by undertaking their duties in nursing both at the bedside and away from the bedside.

The full program theme was explored by Dr. Rachel Hughes, Professor Sabe Sabesan and Associate Professor Gail Garvey. Dr. Hughes presented on the inequity of access to cancer care for those patients in the adolescent or young adult (AYA) group. Dr. Hughes spoke on the differences in cancer care needs in the AYA group and referred to barriers of small patient numbers, geographical dispersion, developmental factors and insufficient specialist support to optimise patient outcomes in this cohort. Professor Sabe Sabesan addressed solution based care for those patients with cancer living in rural and remote regions of Queensland. He inspired delegates with the Telehealth initiative that had been rolled out in Queensland enabling cancer care closer to home supported by partnerships in community healthcare. To round out the program, Gail Garvey gave an enlightening address on the disparity of outcomes in Aboriginal and Torres Strait Islander people affected by cancer. She highlighted the need for healthcare solutions for all, independent of location, culture and race.

An impressive 105 abstracts were submitted, with 45 offered podium presentation, 44 offered poster presentation and only a small number rejected or withdrawn. The program ran for a total of 3 days, offering 6 pre-congress workshops/symposia attended by 261 delegates, 5 plenary sessions, 4 breakfast sessions attended by 223 delegates, concurrent sessions and a poster display.

A number of CNSA committee meetings took place including the CNSA AGM, CNSA member forum, CNSA Specialist Practice Network Meetings and meetings of both the Research and Education Standing Committees of CNSA.

CNSA marketed Congress through numerous avenues including Facebook, Twitter, use of promotional Congress slides by Regional Groups, Congress flyers and posters, regular e-blast notices and advertising through various societies including COSA, ISNCC, Cancer Institute NSW, Lung Foundation, New Zealand Nurses Organisation (Cancer Nurses Group), College of Nursing, Palliative Care Australia, Australian College of Nurse Practitioners and Australian Practice Nurses Association.

An unprecedented level of industry support ensured Congress 2016 was a huge success for CNSA as a society. The large exhibition was supported by 4 Major Congress Partners, BMS, Hospira, MSD and Roche. BMS also supported an industry education dinner on the Thursday evening, attracting more than 100 attendees. The exhibition was sold out with 65 exhibitor and sponsor booths occupied, hosted by 45 different industry, pharma and not-for-profit groups. Delegates and exhibitors were offered the opportunity to mingle with colleagues and friends at the Welcome reception and at the Congress dinner. More than half of all delegates enjoyed the Welcome reception and more than 200 attended the Congress dinner.

To engage with industry the exhibitor passport competition was repeated in 2016. An iPad mini was offered as the industry passport prize which inspired hundreds of delegates to actively engage with industry throughout the exhibition space. This initiative again proved successful as evidenced by industry evaluation and feedback.

Annual Congress 2016 was the most financially successful Congress in history, with \$422,675 in support and exhibition sales, an increase of over \$28,000 from the 2015 Winter Congress in Perth. After disbursements and management fees were paid, CNSA netted a record net profit for 2016 of \$249,932.71 (inc. GST).

Best Clinical Research Paper was awarded to Natalie Bradford, Best Clinical Practice Paper awarded to Joanne Shaw, Best Poster Award awarded to Danielle Spence, Best Poster Award – People's Choice awarded to Rachel Brown and First Time Presenter Awarded to Alison Marven. All prize recipients were awarded a cash prize of \$250.

EDUCATION STANDING COMMITTEE

The Education Standing Committee meet monthly via teleconference. The committee is responsible for leading the review of CNSA travel grant applications. This year, 14 grants were received, and eight were successful. Seven grants provided support for attendance at the 20th CNSA Annual Congress and the remaining grant funded a member to attend an international nursing conference.

In addition to the collaborative committee responsibility for reviewing travel grant applications, each committee member is designated to a specific portfolio. Historically portfolio allocation has worked well, although in 2017 the main focus for the Education Standing Committee has and will be on the collaborative efforts towards the special project, "The minimum safety and education requirements for nurse administration of antineoplastic drugs." Other portfolios focus on the Cancer Nurse credentialing, EEN and CPD.

In the past reporting period, the committee undertook a review to update the process for evaluating grant applications. The completed review saw the incorporation of a guiding template for reviewer reference and the adoption of exemplars to guide the process of moderation. The committee also reached consensus on the minimum requirements and scores for grants to be considered for awarding. For 2018 travel grant applications, the committee will set a specified date from which the applicants membership must have been in place. This step is expected to remove any ambiguity in meeting all grant criteria. In addition, exemplars of successful grants will be made available to applicants through the CNSA website to support members to submit quality applications.

A key outcome of the Education Standing Committee in 2016-17, saw the publication of work undertaken as a scoping exercise into Enrolled Nurse administration of antineoplastic agents, in the Australian Journal of Cancer Nursing. The completed work by the committee has provided a base line for the development of the review process for the position statement, referenced below;

The focus for 2017-18 is to update the CNSA Position Statement on the minimum education and safety requirements for nurse administration of antineoplastic drugs. The first stages of this project have been completed and a comprehensive literature review will be conducted to ensure the new position statement is informed by current evidence.

RESEARCH STANDING COMMITTEE

The Research Standing Committee meets via teleconference three to four times each year and undertakes assigned tasks via email follow-up outside of dedicated meetings. The committee provides general research advice to members, connections to cancer researchers, mentoring options, review of project proposals, review of publications

including conference abstracts and reviews and administers the request for surveys to the

membership via eblasts.

Additionally, the Research Standing Committee is responsible for leading the review of CNSA research grant applications. In this reporting period, nine grants were received, two were successful and awarded;

• Renee Xiangfeng, awarded \$9,499

Understanding Cancer Pain Management Experiences and Needs of Chinese Migrants in Australia: a mixed method study.
Julie Flynn, awarded \$5,500

Evaluating current methods for effective decontamination of needleless connectors: A pilot randomised control trial.

In the 2016-17 reporting period, the committee undertook a review to update the process for evaluating grant applications. In doing so, the committee considered the grant closing date and agreed that in order to maximise the benefit of research workshops incorporated into the Annual Congress, the closing date would move to September 30 in each year. This change has been reflected on the CNSA website.

A key outcome of the Research Standing Committee in 2016-17 was the research workshop for novice researchers at Annual Congress in Cairns in May 2016. Through the workshop, participants received mentoring and assistance to develop and write a research grant application. The workshop was well received and will form the basis of further research workshops planned for future Congress programs.

The priorities of the Research Standing Committee in the coming year include;

- Review of strategic direction for CNSA research and contribution of Research Standing Committee
- Review of grant expectations regarding significance to cancer nursing
- Establish Annual Congress plan to establish an embedded cancer nursing research stream
- Decrease review turn-around time to within two weeks
- Revision of Committee Terms of Reference

I would also like to acknowledge the many other members that actively participate on these committees, all with important roles and duties. However, space constraints prevent

detailing their names and positions. The dedication, commitment and hard work of these, and all the members of the RG committees are greatly appreciated by the CNSA Executive and the wider membership.

Over the past 12 months, the RG committees have organised an impressive array of educational events, offered in various formats, such as; breakfast workshops and seminars, half-day symposiums, and dinner presentations. These events covered topics across a range of clinical issues, new frontiers in treatments, current research, leadership and professional development, and supportive care. The Regional Groups have also continued to collaborate with partner organisations in hosting educational events, such as the HSANZ Nurses Group, and the Victorian Palliative Nurses Group.

The RG Committees should be congratulated on their commitment to providing financial support for their members in various ways. The WA, Hunter and SA RGs provided travel grants to assist with the cost of airfares, accommodation and registration to attend the CNSA Annual Congress. The Victorian RG continues to provide a travel grant in honour of Nicole King, named the Nicole King Memorial Educational Grant. The SA RG sponsored six members from South Australia, and one member from the Northern Territory to attend MASCC in Adelaide.

All the RGs provide some funds, or grants to assist members from regional or rural areas to attend educational events. This is generally in the format of funds to assist with transport and accommodation costs. It is reassuring to note the increased focus of the RGs to support regional and remote cancer nurses to participate in educational and professional development activities. The RGs have continued to develop and maintain strong relationships with pharmaceutical and health related industry groups. It is through these collaborative partnerships and sponsorship that the aforementioned activities are possible.

The NSW Hunter RG committee meet on the first Tuesday of each month. membership at 323.

The NSW Hunter RG has welcomed an increasing number of attendees at educational events in the past year. To accommodate this, and based on feedback, the committee elected to switch the standing venue location for NSW Hunter RG events to Noah's at the Beach, a location that accommodates and draws consistently high numbers of attendees. The committee ultilises the CNSA website to market local events and benefits from the inbuilt event registration system managed by the CNSA Administration Officer. Members are supported to attend these events without co-payment, and non-members are encouraged to join CNSA through imposing a registration fee for attendance at these events. We are proud to have maintained the focus of having cancer nurses present at most of our educational events.

The NSW Hunter RG group has experienced challenges with increasing regulatory constraints imposed on pharmaceutical sponsorship. The NSW Sydney Regional Group (RG) committee meet every second month in addition to meeting at the three educational events held throughout the year. The committee also meet annually to plan the educational events and set a budget for the year ahead. The committee has undergone some recent changes in the 2016-17 reporting period. Angela Whittingham and Suzannah Walden joined the NSW Sydney RG committee and Natalie Byrne resigned from the committee. On behalf of the NSW Sydney RG, I would like to express my immense gratitude to Natalie for the many years she has been on the

committee in the role as Treasurer. We continue to look for opportunities to increase our membership which is disbursed across metropolitan, rural and remote areas, representing members from private and public healthcare settings, academic institutions, and not-for-profit organisations. The NSW Sydney and NSW Hunter RGs combined, recorded a 1% membership growth at the close of the reporting period, with membership at 323.

Our goal for the last 12 months was to continue to consolidate our finances and enhance the educational opportunities, with diverse topics, to truly benefit members across NSW. This included providing financial assistance to attend meetings and travel expense support for members outside the 50km radius of Sydney. We have been able to provide regional members with support to attend education sessions in 2016 and will continue to promote this. 2016 saw some changes to the original committee with the resignation of the Deputy Chair in August 2016. Three other committee members nominated to complete their final terms in December 2016 after serving several years. A special mention and thanks to Heather Pearse who served on the South Australian Regional Group (SA RG) both pre and post its renewal, in a number of roles, and was one of three committed members that kept the Regional Group from dissolving during a period of inactivity in the early 2010's.

A call for nominations last year secured us two new committee members but unfortunately family commitments forced one member to resign shortly after taking office. The South Australian RG committee meet every month and meet annually in December to establish goals and plan the coming year.

The strategic goals of the SA RG have focused on promoting sustainability, both through actively exploring committee succession planning and financial sustainability through sponsorship remodeling, based on seeking annual group sponsorship rather than event sponsorship. The changes to the committee along with a new employment opportunity for the Chair has seen our goals progress slower than we had hoped. Succession planning has been difficult with members stating that they love attending the meetings but find committing to additional voluntary hours outside of their normal work commitments difficult. While the annual sponsorship packages have created more financial stability for the group, local funds have been more difficult to secure in the 2016-17 year with industry allocating more of their local dollars towards attendance at the CNSA Annual Congress planned in Adelaide in June 2017.

Promoting membership growth through engagement with our rural colleagues, targeting workplaces that are underrepresented and actively promoting the membership benefits of CNSA at educational events has seen membership grow 1% at the close of the reporting period, with membership at 103.

Members are supported through the provision of quality local educational events, resource sharing via group enewsletters and financial support to attend conferences and educational events relevant to cancer nursing. Rural members whilst supported to attend educational events in Adelaide have reported that getting the time off work to attend events is difficult, despite grants being allocated specifically to assist rural members with some of the associated costs of attending.

In July 2016, the SA RG allocated financial support for six members to attend MASCC in Adelaide, this was in addition to offering a Northern Territory member a grant covering the accommodation, travel, ticket to the President's ball and registration to attend MASCC in Adelaide. In 2017, funding for three grants has been allocated to support attendance at the CNSA Annual Congress in Adelaide, one of which is specifically allocated to a rural member.

Events are communicated to both members and non-members electronically via a service agreement with a public relations agent at scheduled time frames prior to events. This service provides an online registration program, collation of details and creation of all event-marketing materials for each event. From January of 2017, we have utilised the online registration system offered on the CNSA website and e-blasts via the CNSA server have been used in conjunction with the agent already in use to maximise distribution. The mailing list is maintained by the Chair and is comprised of both member and non-members who have attended previous events.

The past year for CNSA Victorian Regional Group (VIC RG) has been filled with many changes. After 10 years of service to the West Australian Regional Group (WA RG), Cheryl Penter resigned from the committee. We currently use an external provider for advertising events to members and non-members. This service provider also assists with IT services on the day of events and coordinates post-event evaluations. We contribute to the national newsletter twice yearly.

As at the end of the reporting period, the cumulative net assets held in relation to the WA RG was \$91,218.92.

Thank you to everyone who has contributed to the Breast Oncology Specialist Practice Network (Breast SPN) in anyway in the last 12 months. We, as cancer nurses have many competing priorities, both within our professional and personal lives. Your efforts towards the goals of this group are greatly appreciated. Membership to the Breast SPN was down 25% at the end of the reporting period, with 214 members.

The strategic goals for 2016-17 reporting period focused primarily on the revision of the Principles for Nursing Practice in the Management of Post-Surgical Seroma for Breast Cancer. Originally published in 2008, this document has gone through a rigorous process of review and re-writing by a diligent working party formed in early 2016. It is very pleasing to

be a member of a group of such knowledgeable cancer nurses. This document is now in the final stages of review and will be available through CNSA in the Member Hub of the website.

The goals for the Breast SPN will be tabled at the SPN meeting to be held at Congress in Adelaide, with consideration towards developing further teaching aids for seroma management, participation in Cancer Australia projects and the possibility of forming a working party to review the Breast Care Nurse Competency Standards. Associations with stakeholders such as Cancer Australia, Breast Cancer Network Australia, and the McGrath Foundation continue with active participation in strategic planning and advisory groups as required.

Sponsorship to support the educational offering of the Breast SPN within the reporting period was provided by the McGrath Foundation. This sponsorship enabled the Breast SPN to offer a breast cancer specific pre-congress symposium in Cairns as part of the 19th Annual Congress. The event was held as a full day event and attracted more than 100 nurses. It was determined that there would not be a specific breast cancer symposium component in the 20th Annual Congress in Adelaide in 2017, due to the abundance of breast cancer specific conferences held in 2016, namely Leura and COSA.

The last year has seen many changes within the Cancer Nurse Practitioner Specialist Practice Network (CNP SPN) committee. Early in the year Sue Bartlett left the committee and at the end of 2016 Nicole Loft and our previous Chairperson Keith Cox OAM resigned. Early this year Samantha Gibson resigned from the Secretary position to take on the role as CEO of CNSA. This position remains vacant and is expected to be filled shortly. With committee representatives from across the country, the CNP SPN committee meet monthly via teleconference. In addition, the committee meet annually

face to face to plan the educational events for the coming year and to set the strategic goals of

the CNP SPN. Each committee member is allocated to a specific portfolio to promote sustainability of the committee and capitalise on the expertise that each committee member brings. Secretarial support is outsourced to take and produce meeting minutes of the CNP SPN.

Membership to the CNP SPN continues to grow. We have members across the country form all states and territories except the Northern Territory. At the end of the reporting period, membership was up 15% with 52 members from all disciplines of cancer care including Medical Oncology, Radiation Oncology, Surgical Oncology, Haematology and Palliative Care. CNP SPN members are supported through free educational offerings and access to financial support of up to \$500 per event towards the cost of attendance at CNP SPN hosted educational events. The CNP SPN aims to have at least two educational events each year. To date the events have been well received with many people coming to both events during the year despite often having to travel interstate.

GYNAECOLOGICAL ONCOLOGY SPECIALIST PRACTICE NETWORK (GYN SPN)

Anne Mellon continued as the Chair of the Gynaecological Oncology Specialist Practice Network (GYN SPN) during the 2016-17 reporting period. Following a call for nominations to join the committee in late 2016, Danielle Carpenter, Jessica Jude, Belinda Zielony and Natalie Williams joined the committee. The committee meet annually at Congress and at other times via teleconference as required. The GYN SPN continues to grow and currently has 180 members up 2%.

The GYN SPN held a successful preconference workshop at the CNSA 19th Annual Congress in Cairns, sponsored by Roche. Topics presented included Indigenous women's participation in cervical screening and its given consequences; treatment side effects and management; future changes to cervical screening; Ovarian Cancer Australia: support

services and the flagship resource, The Resilience Kit; the Rekindle Project; survivorship care plans in gynaeoncology; low risk endometrial cancer follow up project; and the gynaecological oncology specialist nurse project.

An additional workshop was held at the ANZGOG 2017 meeting in Melbourne with the theme of endometrial cancer. Topics presented included an overview of endometrial cancer; current and future trials in endometrial cancer; obesity and diet; exercise; psychological issues; and new approaches to follow up of low grade endometrial cancer.

As Chair of the Radiation Oncology Specialist Practice Network (RON SPN) committee, I would like to acknowledge and thank the RON SPN committee and membership for continuing to raise the profile of radiation oncology nursing within the cancer community. Through collaborative partnerships within the CNSA community, the RON SPN have again been invited to provide speakers for the Victorian RG seminar in June, focusing on 'Nursing considerations in caring for patients undergoing radiotherapy for breast cancer and gynaecological cancer'. The RON SPN aim to engage with other regional groups and have radiotherapy as a part of their education agenda. Membership to the RON SPN rose markedly during the reporting period, up 40% with 166 members.

To meet the professional development needs of the RON SPN membership, two educational events were offered in the reporting period.

The 2016 CNSA Annual Congress Radiation Oncology pre-congress symposium was a great success. It was well attended by oncology nurses and allied health professionals who provided very positive feedback. The agenda highlighted new and emerging technologies in radiation therapy with a focus on the impact of these technologies on our nursing role. This was also an opportunity to share our experience and knowledge on symptom management. I'd like to thank all the expert presenters and Linda Cibau and Jill Graham for co-facilitating a wonderful workshop. We successfully applied for a pre-Congress symposium for 2017 in Adelaide and I look forward to facilitating a day on the multidisciplinary approach to care in radiotherapy.

The VIC RG had a strong radiation therapy focus and invited the RON SPN to present at two of their education dinners in the reporting period 2016-17. Ninety delegates benefited from the bringing together of the RON SPN and Victorian Palliative Care group in November 2016 to present on 'Palliative Radiotherapy – medical decisions and nursing management of the person requiring radiotherapy for advanced disease'.

Communication with our membership can be challenging. Being a large national group makes it difficult to deliver face to face meetings beyond the opportunity at Annual Congress. We aim to keep our members up to date with current topics of interest and provide an opportunity to share experiences and practices. Gabby Vigar has taken over the production of the newsletter which we contribute to twice yearly and encourage member contributions.

VASCULAR ACCESS DEVICE & INFUSION THERAPY SPECIALIST PRACTICE NETWORK (VAD&IT SPN)



Committee Members included: Nicole Gavin - Chair; Kerrie Curtis - Deputy Chair; Fiona Fuller - Treasurer.

The Vascular Access Device & Infusion Therapy Specialist Practice Network (VAD&IT SPN) formed their Committee in March 2016. Fiona Fuller was appointed as the Treasurer in late 2016. At the close of the reporting period, membership was up by 45% with 259 members.

The second meeting of the VAD&IT SPN meeting was held in Cairns in May 2016 at the Annual Congress. The VAD&IT SPN discussed the Cancer Wiki Guidelines as a group and how we should tackle the task of developing vascular access guidelines for cancer nurses. We decided as a group to focus on *vessel preservation* and *occlusion & thrombosis*.

Cancer Wiki Guidelines has a comprehensive and transparent way of searching, appraising and

reporting the literature in relation to clinical questions. As the Guidelines are available on-line, updates can be made as new literature is published. This ensures the resource provides the most up-to-date evidence for cancer nurses. The VAD&IT SPN plan for Nicole Gavin to undertake some training with Cancer Wiki. It was expected that this would have been completed at the end of this reporting period, however due to competing commitments with PhD studies this has been delayed.

The primary focus of the VAD&IT SPN in the coming year is to update the CNSA Central Venous Access Device (CVAD) Guidelines, originally published in 2007. Cancer Council Australia has agreed to host our guidelines on their Cancer Wiki Guidelines. This format means that the VAD&IT SPN can be appraising the evidence for a few clinical questions at a time and the guideline can be updated as new evidence becomes available. The CNSA CVAD Guidelines will comprise three broad topics and the CVAD Guideline Leads will be made up of CNSA members as identified below.

To support the professional development needs of the VAD&IT SPN, three educational events were offered within the 2016-17 reporting period. Sponsorship to support the educational offerings of the VAD&IT SPN were provided by industry sponsors: Hospira, 3M, Bard Medical Australia, Teleflex, BD and Medical Specialties Australia. This sponsorship enabled delivery of educational events as outlined below:

• May 2016 - Annual Congress Cairns

Delivered as a pre-Congress Workshop at the 19th Annual Congress in Cairns. The workshop, sponsored by Hospira, *'Whose IV line is it anyway?'* was well supported and received by the 60 delegates in attendance. The workshop highlights were the inclusion of two international vascular access experts, Nancy Moureau (supported by Teleflex) and Jocelyn Hill (supported by Angiodynamics). Nancy Moureau and Julie Flynn focused on infective complications and Jocelyn Hill and Sarah Northfield concentrated on mechanical complications.

• Victorian event 2016

Victoria held its first vascular access education and discussion forum in mid-November. Forty five enthusiastic delegates from across the state of Victoria attended and teleconferenced in to listen to Prof. Sam Keogh (Queensland University of Technology, President of AVATAR and AVAS), Peter Haywood (Melbourne Health) and Kerrie Curtis (Austin Health). The topic was what evidence existed for vascular access. This lead to a discussion about what we wanted in the way of future vascular access education.

• Victorian event 2017

The topic for the 2nd Victorian event to be held on March 30th is *Everything dressings! Evidence, gaps and the future. Education and discussion.* Dr. Amanda Ullman from Brisbane teleconferenced in to speak about 'Dressings. What we know and don't know: A paediatric perspective' and Kerrie Curtis discussed 'Dressings. Securement: Evidence and gaps'.

As at the end of the reporting period, the cumulative net assets held in relation to the VAD&IT SPN was \$2,214.49.

The Cancer Nurses Society of Australia Incorporated Notes to the Financial Statements For the year ended 31 March 2017

The financial report covers The Cancer Nurses Society of Australia Incorporated as an individual entity. The Cancer Nurses Society Australia is an incorporated association incorporated and domiciled in Australia.

The principal activities of the Society during the year was to act as a resource to cancer nurses around Australia through the provision of services which aim to advance cancer nursing education, practice and research.

The functional and presentation currency of The Cancer Nurses Society of Australia Incorporated is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

Note 1. Basis of Preparation

In the National Executive Committee members' opinion, the Society is not a reporting entity since there are unlikely to exist users of the financial report who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. This special purpose financial report has been prepared to meet the reporting requirements of the *Associations Incorporation Act 1991 (ACT)* and the *Australian Charities and Not-for-profits Commission Act 2012*.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101, Presentation of Financial Statements, AASB 107 Statement of Cash Flows, AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054 Australian Additional Disclosures.

Note 2. Summary of Significant Accounting Policies

The accounting policies that have been adopted in the preparation of the statements are as follows:

(a) Income Tax:

The Society is exempt from the payment of income tax pursuant to Section 50-5 of the *Income Tax Assessment Act* (1997).

(b) Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Society and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable.

All revenue is stated net of the amount of goods and services tax (GST).

2 Summary of Significant Accounting Policies continued

Donations

The Society, in common with most organisations dependent upon contributions, is unable to establish control over voluntary donations prior to their initial entry into the accounting records, therefore they are recorded on the basis of cash received.

Member Subscriptions

Member subscriptions are recorded on an accruals basis and apportioned across the calendar year of membership.

Grants and Bequests

The Society receives grants and bequests for certain activities. Where a grant or bequest is non-reciprocal, it is recognised as revenue of the Society upon receipt. Associated expenditure for the completion of a grant or bequest is recorded as incurred. Where a grant or bequest is subject to a reciprocal transfer, a liability associated with the reciprocal transfer is recorded upon receipt of the transfer. The income and expenditure is then subsequently reported at the time of the subsequent grant or bequest.

Interest Revenue

Interest is recognised using the effective interest method.

Other Income

Other income is recognised on an accruals basis when the Society is entitled to it.

Net Annual Congress Income

The Society contracts a professional Events Co-ordinator to manage the staging of the Annual Congress including the receipt of revenue and payment of expenses in relation to the event. Documents detailing the income and expenses have been received from the Events Co-ordinator together with a reconciling statement. Revenues and expenses associated with the Congress are recognised through the Statement of Profit & Loss and Other Comprehensive Income in the year the Congress is conducted. In the period in the lead up to the Congress, expenditure is incurred and income received which is taken up as prepayments and unearned income respectively. Where there is an excess of funds received by the Events Co-ordinator above an agreed limit, these funds are remitted back to the society and retained within the cashflows.

(c) Goods and services tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of GST.

The net amount of GST recoverable from, or payable to, the ATO is included as part of receivables or payables in the statement of financial position.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows. 11

(d) Property, plant and equipment

Each class of property, plant and equipment is carried at cost less any accumulated depreciation and impairment.

Items of property, plant and equipment acquired for nil or nominal consideration have been recorded at the acquisition date fair value.

Depreciation

Property, plant and equipment is depreciated on a straight-line basis over the assets useful life to the Society, commencing when the asset is ready for use.

The estimated useful lives used for each class of depreciable asset are shown below:

Fixed asset class	Useful life
Office Equipment	3 years
Computer Equipment	3 years
Web site Development	3 years

At the end of each annual reporting period, the depreciation method, useful life and residual value of each asset is reviewed. Any revisions are accounted for prospectively as a change in estimate.

(e) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held on call with banks and other short-term highly liquid investments with original maturities of three months or less.

(f) Employee benefits

Provision is made for the Society's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

(g) Income in Advance

Income in Advance includes member subscriptions, which have been received for the 2017 membership year, (Refer to note 2 (b)) and Annual Congress income received (Refer to note 2 (b)) or other future income such as sponsorships, which may cover the full proceeding calendar year.

(h) Comparative Figures

Comparative figures have been adjusted to conform to changes in presentation for the current year where required by accounting standards or as a result of changes in accounting policy.

(i) Other Current Assets

Prepayments included in other assets primarily relates to prepayments for the future Annual Congress.

(j) Trade and Other Payables

Trade and other payables represent the liabilities for goods and services received by the Society that remain unpaid at year-end. Trade payables are recognised at their transaction price. They are subject to normal credit terms and do not bear interest.

Note 3. Critical Accounting Estimates and Judgments

The National Executive Committee make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

Key estimates - receivables

The receivables at reporting date have been reviewed to determine whether there is any objective evidence that any of the receivables are impaired. An impairment provision is included for any receivable where the entire balance is not considered collectible. The impairment provision is based on the best information at the reporting date.

Note 4. Nature and objects of the Society

The Society is an association incorporated under the *Associations Incorporation Act 1991*. Its object is to determine and regulate professional standards and competencies for cancer nursing practice and education, facilitate research and standards in the area of cancer nursing, act as a resource for the development and dissemination of information relating to new technologies in cancer nursing, ensure that cancer nurses perspectives' are evident in national nursing debates, actively lobby government on issues relevant to cancer nursing and collaborate locally, nationally and internationally with other organisations involved in the development and provision of services to people with cancer.

In the event of the Society being wound up, the members undertake to contribute to the assets an amount not exceeding the ordinary membership fee of the Society.
