

Silicosis Claim Overview

WHAT CAN I EXPECT

If you've been exposed to silica dust and you suffer from a silica related disease, you may be able to bring a claim.

We understand that your case is unique. However, please see the below in relation to an outline of the general process, the work we can do for you and the potential likely fees.

iCARE, DUST DISEASES CARE, AND DUST DISEASES TRIBUNAL

If you were **an employee** and exposed to silica dust during your work in NSW, you maybe able to make a claim through **iCare, Dust Diseases care (iCare)** and a claim for lump sum compensation through the **Dust Disease Tribunal**. iCare provides a fortnightly payment, medical expenses and ongoing support. At the same time, you may be able to bring your claim to the **Dust Diseases Tribunal** for compensation and we will assist you through both avenues.

If you were self-employed or exposed in a non-occupational way such as a home renovation or washing work clothes and weren't an employee, your claim will be resolved by the court. The **Dust Diseases Tribunal** is the specialised court in NSW which deals with these claims. If you are successful, you may be eligible for a lump sum compensation payment.

If you have been diagnosed with silicosis, compensation may include amounts for:

- + Pain and suffering and loss of enjoyment of life
- + Medical expenses
- + Loss of income
- + Cost of assistance around the home, in the garden and nursing care (even if that assistance is being provided by relatives and friends)
- + Out of pocket expenses, such as travel to medical appointments

POTENTIAL ADDITIONAL BENEFITS

In addition to compensation from **iCare** or court proceedings in the **Dust Diseases Tribunal**, if you are no longer performing your normal work duties as a result of your injury, you may be entitled to a disability benefit through your superannuation fund. We can conduct an obligation free assessment to find out if you may be entitled to a payment.

PROCESS OVERVIEW

Every case is different, but there are a number of steps you may go through in the process of your case. Our knowledgeable and caring team of lawyers will guide you through all of these stages to help ensure you get the best possible outcome.

Get in touch

We'll obtain some basic information from you concerning your health and make an appointment for you to meet with our team.

Attend your free initial appointment**

This gives you the opportunity to find out if you may have a claim and discuss your options so you can make the best decision for you.

03

We'll obtain medical evidence

We'll obtain all medical material needed to support your claim.

04

Your case will likely settle at the pre-trial stage

All cases are the subject of pre-trial negotiations, and the vast majority resolve at this time.

If a settlement is reached, we have a dedicated staff member whose job it is to finalise everything and get any money to you as quickly as possible.

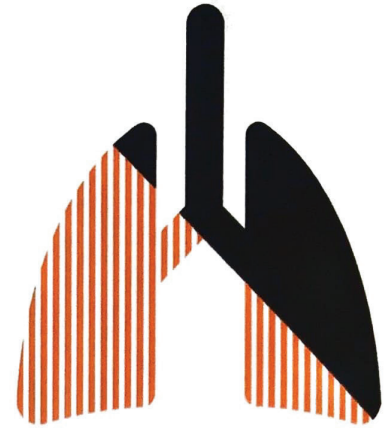
Court proceedings

Most cases do not reach this point. If yours does, we'll guide you every step of the way to help you get compensation.

HOW LONG WILL IT TAKE?

Usually, silicosis claims take only months to resolve. If need be, the claim may be resolved within weeks or days for urgent claims. This is to help ensure you are able to receive your compensation within your lifetime.

Helping to look after you and your family

Silicosis claims can be complex. We'll guide you through the process and work with you to help get a resolution as quickly as possible so you and your family can concentrate on your health.

Q. Do I have to pay anything upfront?

When we do, it'll be on the fixed fee basis you agreed to and are expecting, so there are no surprises.

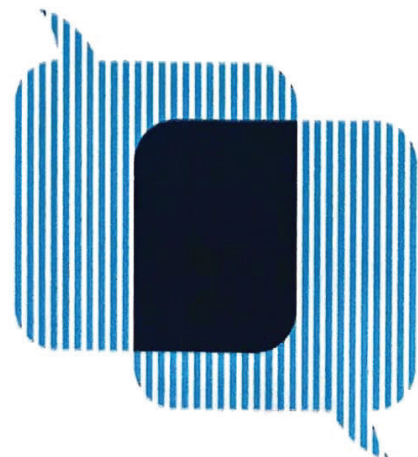
Our fully qualified team has extensive social work knowledge, skills, and experience gained in working in health services and community sectors.

If you are unsuccessful you may still be liable to pay third party costs and disbursements. Our No Win, No Fee* arrangement is not available for every matter, eligibility is required.

Q. Do you take a percentage of my settlement?

No, our fees are fixed so you will know the likely fees payable to us for our work on your case at your first appointment if your case is successful.



COSTS

NO WIN, NO FEE*

We won't charge you until the claim is resolved. And we'll only charge for our work completed if you are successful in the claim so it's in our best interests if you win. We'll further explain our No Win, No Fee* policy and conditions that apply in our free initial appointment** with you.

OUT OF POCKET COSTS

Disbursements (the legal jargon for expenses) are for those documents or services we need to buy to properly investigate and process your claim to give you the best chance of success. These can include:

- + **Clinical notes and reports from your doctors and other health providers, independent medical examinations and reports**
- + **Other reports, such as accountant and vocational assessments**
- + **Investigator services, expert witnesses and other services**
- + **Internal Special counsel, Barristers and Court fees**

We will not require you to make payment of or contribution towards any of the disbursements incurred on your behalf. You will only be required to repay the disbursement from your settlement if your claim is successful.

RECOVERABLES

Legal costs are made up of two things:

- + **Slater and Gordon's fees – typically you'll only pay these if you're successful.**
- + **Out of pocket expenses (as outlined above).**

If you win, the other party will most likely need to pay part of your legal costs. If this is the case, we will provide you with estimates for what the other party will likely need to contribute.
